WHEREAS, the Knox ("City") Redevelopment Commission ("Commission") adopted a declaratory resolution on July 30, 1997, as amended on December 13, 2004, and as further amended and restated on October 30, 2015 (collectively, "Declaratory Resolution"), as confirmed by a confirmatory resolution adopted on December 3, 1997, as amended on November 23, 2015 (collectively, "Confirmatory Resolution"), establishing the boundaries of the Knox Redevelopment area ("Original Area"); and

WHEREAS, the Declaratory Resolution and the Confirmatory resolution are hereinafter collectively referred to as the "Area Resolution";

WHEREAS, the Area Resolution approved the Redevelopment Plan ("Original Plan") which Original Plan contained specific recommendations for redevelopment in the Original Area;

WHEREAS, the Area Resolution established an allocation area in accordance with IC 36-7-14-39 ("Original Allocation Area"), for the purpose of capturing property taxes generated from the incremental assessed value of real property located in the Original Allocation Area;

WHEREAS, on May 6, 2019, the Commission adopted a resolution amending the Area Resolution ("Amending Declaratory Resolution") and Original Plan to: (i) expand the Original Area and the Original allocation Area by adding the parcel numbers set forth on Exhibit A attached thereto, with some parcels located in the City and some parcels within the jurisdiction of the Starke County Redevelopment Commission ("County Commission"), contiguous with the Original Area and located within the jurisdiction of the County Commission, with such parcels also listed on Exhibit A ("County Area") (collectively, "Parcels") to the Original area and the Original Allocation Area; and (ii) add the purchase or lease of police equipment which will serve the Area and add the purchase, repair and maintenance of signage to the list of projects in the Original Plan, all in, serving or benefitting the Original area (as amended, "2019 Plan"); and

WHEREAS, on May 6, 2019, the Starke County Board of Commissioners assigned jurisdiction of the County Area to the commission to be included in the Parcels;

WHEREAS, IC 36-7-14 and IC 36-7-25 and all acts supplemental and amendatory thereto ("Act") require approval of the Amending Declaratory Resolution and the amendment to the Original Plan by the Knox Plan Commission ("Plan Commission"), which occurred on May 7, 2019 after adoption of the Amending Declaratory Resolutions; and

WHEREAS, the Act requires the approval of the action of the Plan Commission by the Common Council of the City;

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF KNOX, INDIANA, THAT:
